### **What are the four mandatory units required for IOSH Level 3 certification?**

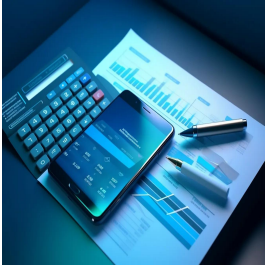
