What are the four mandatory units required for IOSH Level 3 certification?

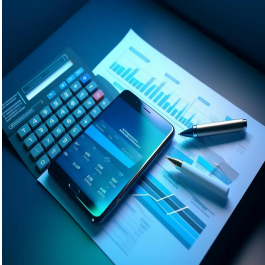
1. Fundamentals of OSH principles and management systems
