## What specific qualifications or prerequisites are needed for participants before enrolling in the course?

No prior certification is required. However, a foundational understanding of business operations or risk management is beneficial. This course is ideal for beginners and professionals transitioning into the field.

## How long is each day's session, and is there a total number of hours required for the entire course?

## What's the difference between disaster recovery and business continuity, and why does it matter for the ABCP exam?

Disaster recovery focuses on restoring IT systems and data after a crisis. Business continuity encompasses all critical business functions, including people, facilities, and communication—not just IT. ABCP candidates must understand this distinction as it's foundational to BCM strategy development and exam success.
