## What specific qualifications or prerequisites are needed for participants before enrolling in the course?

## What's the difference between disaster recovery and business continuity, and why does it matter for the ABCP exam?

Disaster recovery focuses on restoring IT systems and data after a crisis. Business continuity encompasses all critical business functions, including people, facilities, and communication—not just IT. ABCP candidates must understand this distinction as it's foundational to BCM strategy development and exam success.
