Business continuity encompasses all critical business functions, including people, facilities, and communication—not just IT. ABCP candidates must understand this distinction as it's foundational to BCM strategy development and exam success.

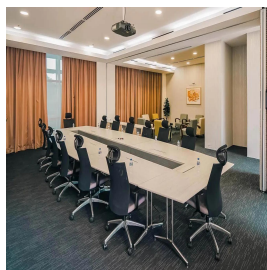

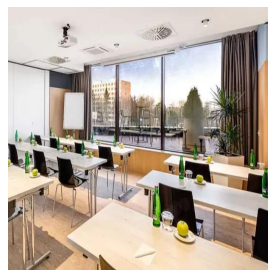
