Each day's session is structured to last around 4-5 hours, totaling approximately 20-25 hours over five days.

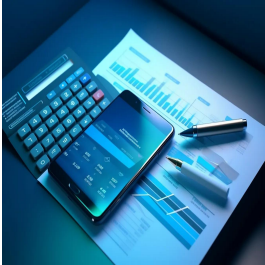
- **How does ISO 50001 differ from other energy management certifications?**

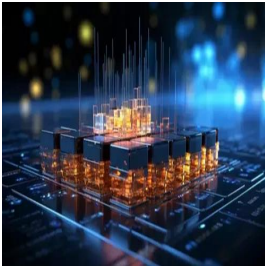

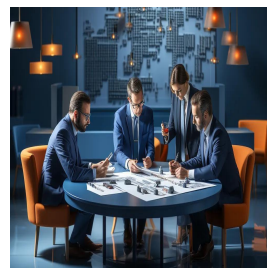

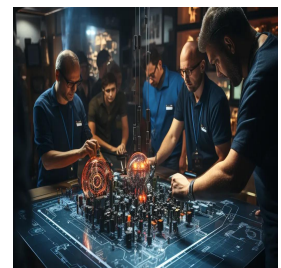
