Each day's session lasts 4-5 hours, making the total duration approximately 20-25 hours over five days.

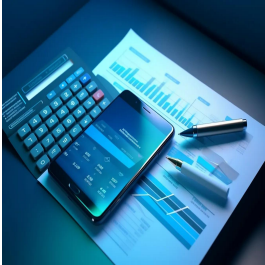
- **What is the role of a Certified CMMC Professional in the assessment process?**
