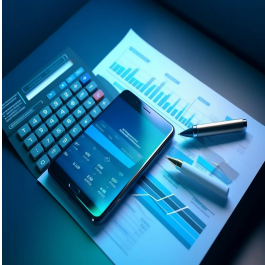
What is the difference between ISO 22301 lead auditor and lead implementer certifications?
