Each day's session lasts approximately 4-5 hours, totaling 20-25 hours of instruction over five days.

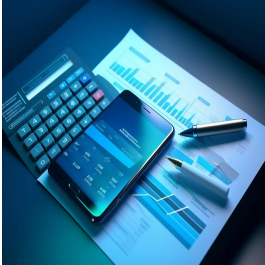
How does operational resilience differ from business continuity management?
