Each day's session is generally structured to last around 4-5 hours, with breaks and interactive activities included. The total course duration spans ten days, approximately 40-50 hours of instruction.

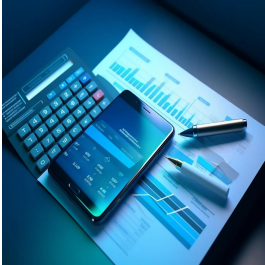
What are the four mandatory units required for IOSH Level 3 certification?
