How does a post-clearance audit differ from an internal audit, and why is it important?

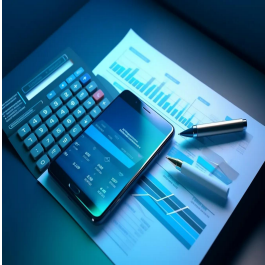
