## Course Overview

## **FAQ**

### **What specific qualifications or prerequisites are needed for participants before enrolling in the course?**

Participants should have prior knowledge of Occupational Health & Safety concepts, the PDCA cycle, and management system principles. Professional experience in HSE, QHSE, operations, compliance, or internal auditing is strongly recommended. The course is suitable for participants who meet, or are close to meeting, Lead Auditor certification eligibility requirements, including relevant work experience in OH&S management or auditing.

### **How long is each day's session, and what is the total duration of the course?**

Each day is typically structured to run for approximately 6–7 hours, including breaks, workshops, and audit simulations. The total course duration spans 10 days, delivering approximately 60–70 hours of structured instruction, practice, and assessment activities.

### **Is this course focused more on theory or audit practice?**

The course maintains a balanced approach between ISO 45001 technical understanding and practical Lead Auditor skill development. While theoretical foundations are covered to ensure correct interpretation of the standard, strong emphasis is placed on audit planning, evidence evaluation, nonconformity writing, audit reporting, and real-world audit decision-making.



## **How This Course Is Different from Other ISO 45001 Lead Auditor Courses**

This ISO 45001:2018 Lead Auditor Training Course is designed as a corporate-grade, professional auditing program that integrates certification readiness with real operational and governance value. Unlike generic Lead Auditor courses that focus primarily on clause interpretation, this program emphasizes applied auditing judgment, leadership responsibility, and audit effectiveness.

The course connects ISO 45001 requirements, ISO 19011 auditing principles, and real certification audit scenarios into a single structured learning journey. Participants gain insight into how auditors evaluate risk, interpret evidence, determine nonconformity severity, and assess management system effectiveness—not just how clauses are written.

By focusing on both Lead Auditor certification readiness and professional audit competence, the course supports organizations in developing auditors who can confidently lead internal, supplier, and third-party OH&S audits, contribute to continual improvement, and strengthen organizational safety governance well beyond the certification process.
