FAQ

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

No formal prerequisites are required. However, experience in public health, health administration, community health, or health policy enables participants to engage deeply with concepts such as public health ethics, health system decision making, and ethical decision making in public health.

How long is each day's session, and is there a total number of hours required for the entire course?

Each day's session is generally structured to last around 4–5 hours, with breaks and interactive activities included. The total course duration spans five days, approximately 20–25 hours of instruction.

Which ethical challenges are most confusing for new public health practitioners?

New practitioners often struggle with balancing individual autonomy and community protection when applying ethical frameworks in public health, particularly in areas such as public health emergency ethics and health equity and ethics.

How This Course is Different from Other Public Health Ethics & Decision-Making Courses

This course stands out by combining practical leadership development with applied public health ethics and structured decision-making approaches that reflect real-world challenges. Rather than focusing on theoretical discussions, the course emphasizes public health decision making, ethical dilemmas in public health, and public health governance through hands-on exercises and leadership scenarios. Participants explore how to integrate principles such as transparency, accountability, equity, and fairness into daily decision making.

The course also reinforces public health leadership ethics and strengthens the ability to use health policy decision tools for high-impact decisions.
