## Training Methodology:

This course uses an applied, interactive approach combining lectures, case studies, group exercises, and field-based simulations tailored to Gulf construction environments. Each module connects temporary works supervisor training principles to practical site operations, ensuring participants can perform supervisory tasks with confidence.

Through documentation exercises, participants work with inspection forms, permits, and reporting templates that reflect real Gulf project requirements. Discussions focus on temporary works supervision, daily monitoring, communication pathways, and on-site responsibilities. Simulation activities replicate scenarios involving temporary works implementation, risk escalation, and coordination between supervisors, coordinators, contractors, and designers.

Group work encourages collaboration and practical judgment in evaluating temporary works compliance, identifying hazards, and enforcing safe systems of work. While no physical tools are provided, participants gain access to digital supervisory checklists, procedural examples, and documentation samples aligned with regional standards and BS 5975 principles. The methodology ensures supervisors leave with actionable skills required for safe and compliant temporary works supervision.

## **What specific qualifications or prerequisites are needed for participants before enrolling in the course?**

Participants should have prior experience in site supervision, construction operations, or HSE roles. A basic understanding of site documentation, temporary works activities, and safety practices is recommended for optimal learning.

## **How long is each day's session, and is there a total number of hours required for the entire course?**

Each day runs for approximately 4 to 5 hours, including interactive workshops and scenario-based tasks, with the full course totaling around 25 hours of professional instruction.

## **What is the role of the Temporary Works Supervisor compared to the Temporary Works Coordinator?**

The TWS supervises daily on-site temporary works operations, ensuring correct implementation, inspection, and safety compliance. The TWC manages design, procedural control, and overall coordination. The TWS reports findings, monitors activities, and supports the TWC in delivering safe temporary works.
