Each session lasts approximately 4-5 hours, with breaks and interactive activities. The total course duration spans five days, approximately 20-25 hours of instruction.

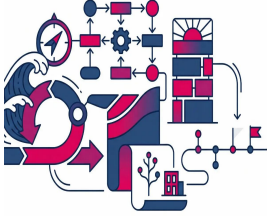
