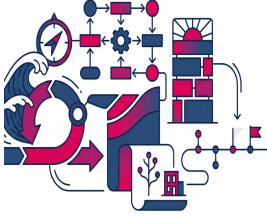
How This Course is Different from Other PMO Leadership & Governance Courses:
