## **FAQ:**

### **What specific qualifications or prerequisites are needed for participants before enrolling in the course?**

## **Is ISO 21001 only for schools and universities?**

No. ISO 21001 applies to any organization that uses a curriculum to support competence development through teaching, learning, training, or research. This may include schools, universities, vocational institutes, corporate training departments, professional training centers, and educational organizations within larger organizations. It does not apply to organizations that only produce or manufacture educational products.

## **How This Course is Different from Other ISO 21001 Foundation Courses:**

This ISO 21001 Foundation Training stands out because it connects the standard directly to real educational operations rather than presenting ISO 21001 as a purely theoretical compliance framework. Participants do not only learn definitions and clauses; they understand how EOMS supports learner satisfaction, institutional credibility, academic governance, curriculum delivery, staff competence, data protection, accessibility, and continual improvement.

The course is designed for practical workplace application in schools, universities, training centers, corporate academies, and education departments.
