Each day's session is generally structured to last around 4-5 hours, with breaks and interactive activities included. The total course duration spans five days, approximately 20-25 hours of instruction.

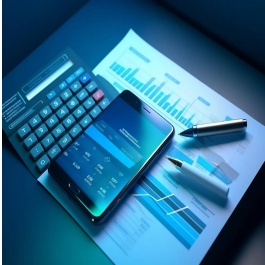
## **What is the difference between ISO 22301 lead auditor and lead implementer certifications?**

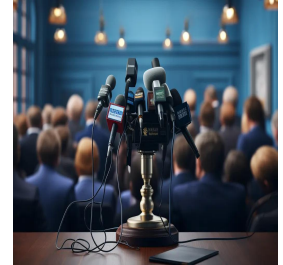

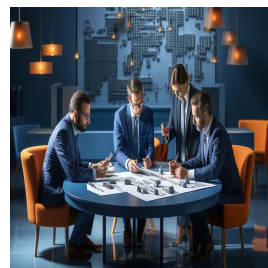

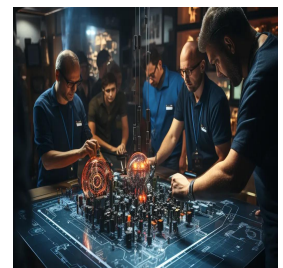
