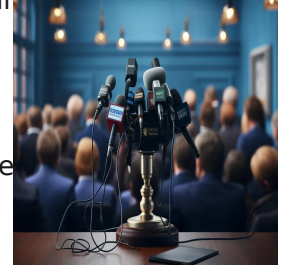

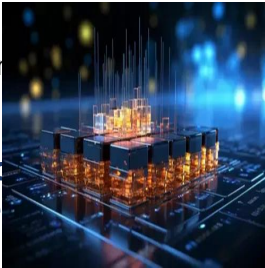

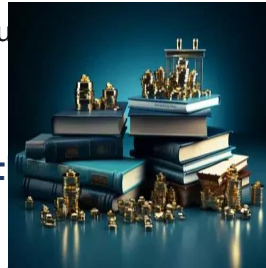

What is the difference between incident response and disaster recovery?

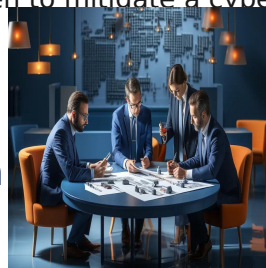

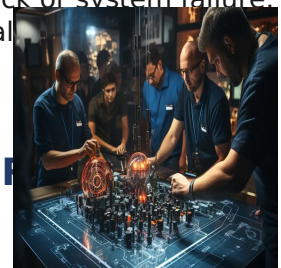
