- **How does ISO 50001 differ from other energy management certifications?**

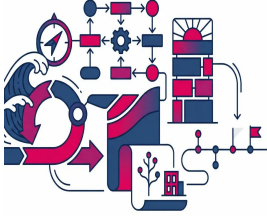
