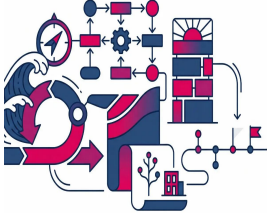
How This Course Is Different From Other Governance Courses
