Course Overview:

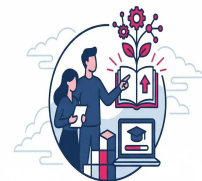

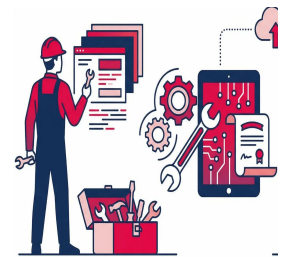
