How do organizations ensure that employee sustainability training translates into measurable impact?

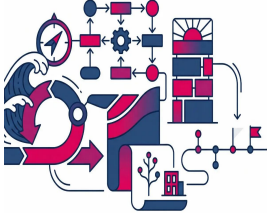
