Each day consists of 4 to 5 hours of instruction, structured discussions, and practical exercises. The complete ten-day course provides between 45 and 50 instructional hours.

What are the biggest legal risks in procurement and contract management?

Major risks include statutory non-compliance, ambiguous contract specifications, failure to enforce liquidated damages, supplier default, and flawed tender evaluation disputes. The course provides structured drafting and evaluation frameworks to mitigate these exposures.
