Day 1: Business Analysis Foundations and Planning

Day 2: Elicitation and Collaboration Practices

- Preparing elicitation activities and selecting appropriate investigation methods

- Confirming and validating elicitation findings against stakeholder business needs
- Communicating business analysis information across technical and non-technical teams

- Synthesizing elicitation records into baseline operational requirements

Day 3: Requirements Life Cycle Management

- Establishing end-to-end requirements traceability from business drivers to solution components
- Maintaining requirements integrity and enabling asset reuse across programs
- Prioritizing business and technical requirements using risk and value criteria
- Assessing formal change requests and evaluating operational impacts
- Navigating requirements approvals and securing baseline stakeholder sign-offs
- Consolidating lifecycle controls to ensure sustained quality and consistency

Day 4: Strategy Analysis and Design Definition

- Analyzing current enterprise state, organizational capabilities, and core constraints
- Defining future state architectures, measurable goals, and target business outcomes
- Conducting risk assessments to quantify solution and operational vulnerabilities
- Developing change strategies and transition architectures for phased deployment
- Structuring requirements architecture and modeling design options
- Comparing alternative design options to establish optimal solution value

Day 5: Solution Evaluation and Value Optimization

- Defining performance measures and indicators to monitor solution results
- Analyzing operational performance metrics to identify capability and value gaps
- Diagnosing technical solution limitations and performance barriers
- Assessing enterprise and cultural limitations impacting solution adoption
- Recommending corrective actions and enhancements to maximize organizational value
- Consolidating end-to-end competencies through an integrated business scenario
