Day 3: Operational Controls and Educational Service Delivery

- Control of externally provided educational services, academic partnerships, and e-learning platforms

- Documentation of internal audit findings, objective evidence, and audit reports
- Structuring formal management reviews, executive input reports, and decision logs
- Managing nonconformities, conducting root cause analysis, and deploying corrective actions

Day 5: Continual Improvement and Certification Preparation

- Continual improvement frameworks tailored to institutional effectiveness and student success
- Review of implementation competency domains and applied scenario evaluations
- Preparing documentation packs and operational records for Stage 1 certification audits
- Managing Stage 2 on-site and remote certification audit assessments
- Resolving audit findings, responding to audit recommendations, and sustaining post-certification compliance
- Action planning for institutional roll-out and final implementation readiness review

Practical Exercises

Participants complete hands-on activities to resolve operational challenges and build execution plans.

- Draft an EOMS scope statement and context analysis matrix for a multi-faculty institution.
- Conduct a gap analysis exercise to map current operational procedures against ISO 21001 requirements.
- Build a risk treatment plan addressing curriculum delivery interruptions and assessment integrity.
- Develop an internal audit checklist covering learner admission, course delivery, and learner feedback workflows.

FAQs

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

There are no formal prerequisites for this training course. Participants will benefit from practical experience in educational administration, quality management, curriculum development, or internal auditing within academic or corporate learning environments.

How long is each day's session, and is there a total number of hours required for the entire course?

Sessions run for approximately 4 to 5 hours per day across five consecutive days, providing a total of 20 to 25 instructional hours incorporating practical exercises and case discussions.

General quality improvement often focuses on isolated academic initiatives such as updating course content or student satisfaction surveys. Implementing ISO 21001 provides a formal management system framework integrating leadership, operational controls, risk management, and formal internal audits for institutional governance.
