Course Overview

FAQ

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

How long is each day's session, and is there a total number of hours required for the entire course?

Each day includes 4–5 hours of training with interactive activities. The total duration is 20–25 hours across five days.

What is the most common challenge organizations face when preparing for major public health events?

The most common challenge is insufficient coordination between sectors, which limits effective public health preparedness, emergency response preparedness, and public health incident management during time-sensitive scenarios.

How This Course is Different

This course is uniquely designed to address the complex realities of public health preparedness for major events by integrating operational, strategic, and health security concepts into a single, comprehensive framework. Unlike general emergency management training, this program focuses specifically on the intersection of major events health preparedness, mass gathering health management, and public health emergency planning.
