- Managing post-tender clarifications and formal award notification protocols
- Contract formation mechanisms and final execution checklists

Day 4: Contractual Risk, Compliance, and Supplier Performance

- Identifying operational, legal, and financial exposures in contract administration
- Managing scope changes, variation orders, and claims resolution workflows
- Supplier relationship management frameworks and partnership governance
- Designing meaningful service level agreements and supplier scorecards
- Dispute avoidance mechanisms, mediation protocols, and escalation paths
- Contract closeout procedures and supplier appraisal reviews



Day 5: Cost Optimization, Procurement Analytics, and ESG

- Total cost of ownership analysis and strategic cost reduction techniques
- Financial risk mitigation: Payment terms, bank guarantees, and performance bonds
- Designing procurement performance analysis dashboards using operational indicators

- Artificial intelligence applications and emerging digital trends in contract oversight
- Developing an institutional procurement and contracting action plan

Practical Exercises

Participants engage in realistic simulations and practical problem-solving sessions throughout the five days.

- Evaluate a tender scenario using two-stage technical and financial evaluation scorecards.
- Review and amend risk allocation clauses within a sample goods and services contract.
- Design a supplier scorecard with key performance indicators and service level agreements.
- Draft an e-sourcing category strategy addressing spend concentration and supply market risks.

FAQs

What specific qualifications or prerequisites are needed for participants before enrolling in the course?

Participants should ideally have at least two years of experience in procurement, tenders, or contract management. A basic understanding of purchasing principles or legal frameworks in procurement is beneficial but not mandatory.

How long is each day's session, and is there a total number of hours required for the entire course?

Each day consists of 4-5 hours of training, including lectures, case studies, and interactive sessions. The full course spans 5 days, totaling 20-25 hours of instruction.

What are the biggest legal risks in procurement and contract management?

Some of the most common risks include non-compliance with legal requirements, misinterpretation of contract terms, supplier disputes, and fraudulent procurement practices. This course will provide insights into mitigating these risks through contractual safeguards and due diligence practices.
