Practical Exercises

Participants engage in structured exercises designed to build practical safety leadership tools.

- Suggested activity: Construct an operational risk matrix and bowtie model for a critical facility task.
- Suggested activity: Design a non-punitive incident reporting workflow with clear escalation triggers.
- Suggested activity: Develop a balanced scorecard incorporating leading safety performance metrics.
- Suggested activity: Audit an operational procedure using ANSI/ASSP Z10 verification criteria.

FAQs

What specific qualifications or prerequisites are needed before enrolling in the course?

There are no formal prerequisites. However, the syllabus is designed for professionals with operational responsibilities in occupational safety, operations management, or risk governance.

How long is each daily session and what is the total course duration?

Sessions run for four to five hours each day across five days, providing twenty to twenty-five hours of structured instruction, interactive case studies, and practical workshops.



What is the difference between proactive safety management and reactive safety reporting?

Proactive safety management uses risk assessments, audits, and leading performance metrics to eliminate hazards before incidents happen. Reactive safety reporting reviews past incidents through investigations to implement corrective controls.
