- Executing the standard five-step process for evaluating site conditions
- Prioritising safeguards using elimination, substitution, and technical isolation
- Administrative controls, safe operating procedures, and protective attire limits

Day 3: Physical Environment and Operational Safeguards

- Fire prevention measures, combustible storage, and emergency egress protocols
- Manual handling load parameters and task-specific ergonomic modifications
- Management of hazardous substances, safety data sheets, and exposure limits
- Machinery guarding standards, electrical maintenance, and lockout isolation
- Workplace welfare provisions: ventilation, lighting, and sanitation requirements

Day 4: Occurrence Reporting, Inquiries, and Culture

- Statutory reporting parameters for occupational injuries, diseases, and dangerous events
- Scene preservation, witness interviewing techniques, and evidence collection
- Determining root causes using sequence mapping and analytical trees
- Formulating remedial action plans and tracking implementation milestones

- Investigation Sequence Mapping: Chart contributing factors for a mock warehouse occurrence.
- Formative Assessment Paper: Complete timed sample examination questions followed by peer scoring.
