Day 1: Safety Foundations and Legal Duties

- Safety supervision and task-specific instruction protocols

Day 4: Incident Investigation and Safety Culture

- Statutory accident, disease, and dangerous occurrence reporting
- Initial response procedures and scene preservation techniques
- Root cause analysis using structured interview and timeline tools
- Corrective action planning and post-incident verification
- Measuring safety culture through leading and lagging performance metrics
- Consultation mechanisms and workforce involvement in safety governance

Day 5: Assessment Strategy and Syllabus Review

- Systematic review of core qualification learning outcomes
- Techniques for analyzing scenario-based assessment questions
- Structuring written answers against grading and marking criteria
- Addressing common assessment errors and descriptive weaknesses
- Consolidated review of risk calculation methods and terminology
- Individual action planning and personal syllabus revision strategy

Practical Exercises

Participants complete structured exercises designed to reinforce core knowledge and exam techniques.

- Hazard Identification Walkthrough: Evaluate a workplace scenario to detect environmental and procedural risks.
- Risk Register Formulation: Complete a standard risk assessment table including control prioritisation.
- Incident Analysis Exercise: Map an accident sequence using fishbone diagramming to determine systemic root causes.
- Mock Assessment Review: Draft structured written answers to sample qualification questions and review against marking criteria.

FAQs

What prerequisites are required before enrolling in this course?

There are no formal academic prerequisites required for enrolment, though general familiarity with workplace environments is beneficial for contextualising the syllabus topics.

What is the daily schedule and instructional duration?

Instruction spans five days with approximately four to five hours of structured teaching, scenario analysis, and review activities per day.
