- Suggested activity: Conduct a mock supplier negotiation addressing price escalation, penalties, and payment terms.
- Suggested activity: Design an operational revenue protection audit checklist targeting inventory shrinkage and invoice errors.

### How does this course address revenue protection?

The curriculum includes dedicated modules examining inventory discrepancy tracking, delivery validation audits, field inspection controls, and data analytics to prevent operating losses and billing leakage.

### What balance is maintained between procurement and logistics?
